Regarding sanction of drivers for Patient Transport Ambulances (PTAs) in districts under "Atal Janani Vahini Sewa" for providing 24*7 transportation facilities to pregnant women for Ante Natal Check Ups (ANCs), Post Natal Check Ups (PNCs) and Back Home Services.

As you are aware that state has procured 188 Patient Transport Ambulances (PTAs) to strengthen the existing fleet of ambulances and is under delivery process. Thus, for the operationalization of these ambulances, you are hereby accorded permission to recruite three drivers for each Patient Transport Ambulance. These drivers may be hired as per Chief Secretary, Haryana Outsourcing Policy, Part-1 for smooth and effective operationalization. Drivers hired for these ambulances may be paid as per DC rate. Selection Criteria approved by National Health Mission, Haryana must be adadhred by districts for hiring of drivers on Outsourcing basis:- As per Service BYE-LAWS of NHM, the Basic Qualification of ambulance driver is as under:-

- Matriculation from a recognized board with Hindi or Sanskrit.
- (ii) Valid Driving License to drive Heavy Transport Vehicle (HMV License), as the case may be at least three years old.
- (iii) He should not be colour blind.
